3) Long Gun Registry

Virginia read a News Release from the Coalition for Gun Control regarding September 13th marking the Fifth Anniversary of Anastasia De Sousa's tragic death at Montreal's Dawson College. That day, a man with a history of mental illness shot 20 students with a legal Beretta CX-4 Storm, a semi-automatic tactical weapon with characteristics of a military assault weapon. In September 2008, the Quebec government's "Anastasia Law" came into effect, strengthening gun safety in the province through enhancing the reporting of high-risk behaviors in connection with firearms. The law further banned the presence of firearms in schools and daycare centres, and on public and school transportation.

7) Upcoming Events

Discussed National Child's Day which is held November 20th and event ideas. Child's Day was enacted in Bill C371, otherwise known as Child Day Act, by the Parliament of Canada in 1993. It commemorates the United Nations adoption of two landmark documents concerned with the Human Rights of all Children and Youths. On "Child Day", we honour our children and The United Nations Declaration on the Rights of The Child on November 20th, 1959 and The United Nations Convention on the Rights of the Child on November 20th, 1989.

The purpose of National Child's Day is to promote awareness about the Convention to Canadians. It is also a day to support Canadian children's rights by voicing your concerns about Canadian Children's rights violations to the Politicians of Canada and to educate our children about their rights and responsibilities.

Virginia will send invite to the Coalition of Child Care Advocates of BC to request a representative attend our November 14th

meeting to provide information on what their group has been working on/is working on and how our Women's committee may be able to assist.
