3.2 RESULTS

Kelly and Maria-Luiza attended a meeting for RESULTS Canada, a non-partisan organization devoted to eliminate extreme poverty by 2020, through lobbying the federal government to: -prioritize international development and increase aid spending and to 0.7% of the Gross National Income (GNI), currently at 0.24% of the GNI.

-increase support for fighting diseases of poverty, including funding mechanisms to fight AIDS, Malaria, Tuberculosis and Polio.

-improve the lives of women and girls, focusing on water and sanitation, education and nutrition RESULTS meets the second Wednesday of the month at Vernon Regional Library.

3.3 Amnesty International

Kelly attended two Amnesty meetings:

3.6 Aston Waikiki Beach Hotel Workers protest

Annette participated in a protest in Waikiki (while on holidays) in support of Aston Waikiki Beach Hotel workers asking for the right to form an Union; and to have meaningful consultation with management which is refusing to talk to the workers. She spoke to them about her experience with PSAC and on everybody having the right to be treated respectfully.

6. Participation in campaigns

Kelly wrote a letter on behalf of the OHRC to Chris Alexander - Minister of Citizenship and Immigration, regarding a petition on <u>change.org</u> on Bill C-24. The bill will expand grounds for stripping Canadian citizenship of individuals who have dual citizenship and are allegedly accused of any activity linked to "terrorism".

7. Investments

Annette presented an update on our investiment to supports KIVA borrowers:

To date, \$108.00 has been paid back on previous investments, with 2 borrowers still paying back as scheduled.

Motion to re-invest \$100.00 to two new borrowers (\$50.00 each) presented by Annette and seconded by Kelly was approved.
