#### 1. Introductions around the table.

## 2. Minutes from previous meetings May 4, 2013 and September 14, 2013

### Review of minutes from September 14, 2013.

Tom motioned to accept financial report – George seconded. All in favour

Tom wanted to thank Sharon on behalf of the Area Council for all her hard work.

units

Sharon seconded. Elected by acclamation.

BC Area Councils was discussed (see attachment).
