## **Discussion**

## 1. New member: CIU

The Okanagan Human Rights Committee (OHRC) welcomed Carolyn McGillivray, representing Customs and Immigration Union (CIU). Carolyn learned about the OHRC during the 2013 PSAC Equity Conferences.

- 2. Committee Status: Letter from REVP Office about the OHRC being inactive.
- Miscommunication inside PSAC, since the annual documentation was previously submitted.
- The OHRC hosted two massive events during the year of 2013: Bullying in the workplace and the Quilts Project.
- The committee has provided more information but has not been advised of status being corrected.
- Members expressed concerns about the whole situation and everyone was in agreement that the committee is very successful and had met the requirements.

### Actions:

If changes on the way the OHRC presents its documents has to be done, a conf call will be asked for clarification of the process and re-evaluation of records.

- Donation of \$100.00 (one hundred dollars) to **Migrant Dreams**, from Canadian director Min Sook Lee, a documentary about the world of women who left their country of origin to work in Canada.

The amount of \$1135.00 (one thousand, one hundred and thirty five dollars) was raised through sales of raffle tickets during the 2013 PSAC Equity Conferences.

Quilt money will be donated next year to CODEV and Plan Canada, to support programs related to human rights.

The small puzzle quilt was presented to Jeannie Baldwin as a momento for the first National Equity Conference and in recognition of her years of human rights work and advocacy.

During the meetings of the Okanagan Womens Committee and Okanagan Area Council and Okanagan Human Rights Committee in November 29th, 2013, representatives Committees discussed the selection of Delegates and Alternates for the 2014 PSAC BC Regional Convention, to maximize participation of members without overlap and consequent loss of seats.
